

COLMEX PRO FREE TRADING COMMISSION PROMOTION FOR EQUITY TRADING ACCOUNTS TERMS AND CONDITIONS

Colmex Pro Ltd (hereinafter called the “Company” or “Colmex Pro”) is a financial services Company incorporated and registered under the laws of the Republic of Cyprus under incorporation no. 260064, having its registered office at 117 Makariou III Avenue & Sissifou (ex Lefkosias-Limnazousas) Street, Quarter of Apostoloi Petrou & Pavlou, 3021 Limassol, Cyprus, (contact number + (357) 25-030036, Email: info@colmexpro.com). The Company is licensed by the Cyprus Securities and Exchange Commission (“CySEC”), under license no. 123/10 to provide investment services through its electronic system, via Internet.

New clients that will open an equity trading account with the Company may trade without trading commissions subject to the terms and conditions indicated in the Section 2 below, by opening an equity trading account and making a qualifying deposit and by accepting the present Terms and Conditions. Participation in this promotion (hereinafter called “the Promotion”) and eligibility for the free trading commissions are subject to the present Terms and Conditions, as well as the Company’s standardised [Terms and Conditions](#), which govern its contractual relationship with its clients.

1. The promotion

This promotion is applicable to new clients who will open an equity trading account with the Company and make a deposit qualifying for the free trading commissions. It is specified that the trading commissions which the client will not be charged include the ECN fees, TAF fees, SEC fees as well as buy and sell commissions as these are further specified on the Company’s [Contract Specifications](#).

2. Terms of participation

- i. The promotion is available to new clients who will open an equity trading account in Colmex Pro 2.0 platform.
- ii. The promotion is active and valid from 01/06/2022 until 31/07/2022 inclusive.
- iii. Participants must open an equity trading account with the Company and make a qualifying deposit of at least USD 2,000, subject to the minimum deposit requirements of the Company.
- iv. It is hereby clarified that the opening of a trading account with the Company is subject to the Company’s registration process and internal procedures, including successfully passing the Company’s appropriateness test, being within the Company’s positive target market and being approved as the Company’s client.
- v. Only clients who accepted the present Terms and Conditions will be able to enjoy this promotion.
- vi. New clients opening an equity trading account: The qualifying deposit for a new client that opens an equity trading account is subject to the minimum deposit requirements of the Company. New clients will not be charged any trading commissions during the first month of trading. For example, if a deposit is approved on 5th of June 2022, the client will be able to trade commission-free until 5th of July 2022.

The first month is calculated from the deposit approval date.

- vii. The client will not be charged any trading commissions during the period mentioned in point (vi) above.

- viii. The commission applicable to the client's trading account will be calculated based on the clients' trading plan as of the day of qualifying deposit and will remain the same until the period of free trading commissions is lapsed.
- ix. Once the trading commission-free period has lapsed, the client will be moved to the trading plan applicable according to the size of his/her trading account.
- x. The client cannot change trading commission plans during the period which the trading commission-free takes place.
- xi. The qualifying deposits are non-cumulative and therefore deposits cannot be aggregated to reach a higher / better tier of promotion. Colmex Pro may, however, at its sole discretion, allow the aggregation of deposits.
- xii. Please note that this is a onetime promotion and clients are not allowed, to benefit twice from the promotion, by making a second eligible deposit and receiving commission discount, unless the Company, at its sole discretion, specifically approves clients to be benefitted twice from the promotion.
- xiii. If a client did not use the free trading commissions which were granted by the Company through a previous promotion and the client participates in this Promotion, the client will trade without trading commissions for a month as mentioned in Point (vi) and once the said period is lapsed, he/she will continue trading without commissions according to the previous promotion.
- xiv. This promotion cannot be used in conjunction with any other ongoing promotion or offer unless the Company, at its sole discretion, specifically approves clients to be benefitted from promotions running in parallel.
